REGULATIONS

International Animated Shortfilm Competition

4th Eksjö Animation Festival September 24-26 2009

1. Animated shortfilms with a running time of no more than 30 minutes are accepted for consideration. Eligible screening format is DVD.
2. Entries must have been produced no earlier than two years prior to the deadline (i.e. after 29 June 2007)
3. Films with other than English dialogue/commentary must have English subtitles. The festival reserves the right to consider exceptions for films with Swedish dialogue/commentary.
4. There are no fees for participating in Eksjö Animation Festival. Participants are not entitled to claim fees for the screening of their films at the festival.
5. Films and other material will not be returned.
6. Entry must be made on the 2009 entry form supplied by the Eksjö Animation Festival. Entry of a film is binding and implies acceptance of the regulations.
7. The deadline for entry is July 5, 2009.
8. Decisions regarding the selection of films will be reached by the end of August 2009.
9. All selected films will be presented in the festival catalogue.
10. In the event of disagreement concerning the interpretation of the regulations, the interpretation of the festival will take precedence.
11. All costs by sending a film to the festival is paid by the sender. Shipments from abroad must be marked "for cultural use only, no commercial value".
12. All participating films in the European Animated Shortfilm Competition compete for the following awards:
 - Eksjö Grand prix
 - Best animation
 - Best design
 - The Jurys Special price
 - ANOBA nomination
 - Audience award
13. The jury is appointed by the Eksjö Animation festival.
